

USEFUL INFORMATION

• The Ice Rink will be open daily from the 30th of November 2019 till 2nd February 2020 from 10 a.m to 10 p.m, weather permitting.

For more information regarding weather and the Ice Rink operation, please visit the SNFCC website www.snfcc.org.

- Admission is free by online pre-registration and each slot lasts 40 minutes. Your pre-registration will be valid if you arrive at least 20 minutes prior to your booking, otherwise your reservation will be cancelled. In the event of operations pause due to bad weather conditions, the pre-registration will be cancelled automatically and you will have the chance to re-book on a new date.
- If you haven't pre-registered through our website, a waiting list will be also available at the waiting queue of the Ice Rink.

Please read carefully the safety regulations and the terms of operation below:

SAFETY REGULATIONS

- · Participants enter at their own risk.
- Participants are obliged to follow the coordinator's instructions in order to avoid conflicts and injuries.
- Participants who disturb or impede other users will be diverged.
- Smoking is forbidden.
- Use of mobile phones or other electronic devices is not allowed within the space of the rink.
- Drinks, food and chewing gum are not allowed due to safety regulations.
- Umbrellas, sticks, and other sharp or dangerous objects are not allowed inside the rink.
- The use of the Ice Rink is not allowed for those who are under the influence of alcohol and/or drugs.
- Participants are not allowed to develop high speed within the rink.

TERMS OF OPERATION

- If participants bring their own skates, these have to be in excellent condition so as not
 to provoke any damage on the rink and to prevent injuries. If the SNFCC staff determine
 that the equipment is inappropriate, then participants have to use SNFCC'S equipment.
- Entrance is allowed to children over 5 years old.
- Children up to 16 years old have to be accompanied by an adult chaperone (during their arrival). For safety reasons, participants may be asked to show a type of identification (passport, ID or other) in order to verify their age.
- The use of gloves and helmets is obligatory for children. It is recommended to bring your personal equipment, however there will be also available children's sizes for borrowing. Moreover, we highly recommend that teenagers and adults use the necessary equipment.
- · Rink operates only for in-line ice skaters.
- Any other activity within the Ice Rink is forbidden.
- Adult chaperones and other visitors are not allowed to enter the Ice Rink.
- · Pets are not allowed within the rink.
- · Participants should be healthy and fit.
- Visitors are not allowed to stay within the fencing of the Ice Rink.

HIGH RISK GROUPS

People with historical cardiovascular disease (including passive) musculoskeletal disorders as well as pregnant women are not allowed to participate in the Ice Rink slots.
