## **MEMBERSHIP PROGRAM PRIZE DRAW TERMS & CONDITIONS**

- 1. The special-purpose limited liability company "Stavros Niarchos Foundation Cultural Center Single Person S.A.," based in Kallithea, on 364 Syngrou Avenue (Taxpayer Identification Number 998092132, Internal Revenue Service FAE Piraeus) (hereinafter "SNFCC S.A."), in the context of the operation of Stavros Niarchos Foundation Cultural Center Membership Program (hereinafter the "Membership Program"), organizes a prize draw to produce eight (8) winners (hereinafter the "Draw"), governed by these terms (hereinafter the "Terms").
- **2.** The Terms, as applicable from time to time, will be posted on the website of SNFCC S.A. "www.snfcc.org" (hereinafter the "**Website**").
- **3.** Eligible to participate in the Draw are natural persons who cumulatively meet the following two conditions:
- **3.1** have an active subscription to the Membership Program (Member, Young, Senior, or Family) on January 8, 2023, and
- **3.2.** have an active subscription to the Membership Program on the date of the actual Draw.

Let it be clarified that, in the case of a Family Membership, only the primary Member of the subscription will participate in the Draw.

Those entitled to participate in the Draw as defined above in this term automatically participate in the Draw, without any other action being required.

Those entitled to participate in the Draw have the right to refuse to participate in the Draw, by means of a relevant written declaration addressed to SNFCC S.A. (either to its physical address in Kallithea, 364 Syngrou Avenue, GR 17674, or to the email address: <a href="mailto:members@snfcc.org">members@snfcc.org</a>), no later than ten (10) days prior to the date of the actual Draw, otherwise they will be deemed to have unconditionally accepted their participation to it in accordance with these Terms, as applicable from time to time.

**4**. The draw will take place at the headquarters of SNFCC S.A., in the presence of a notary public, on a date to be announced on the SNFCC S.A. Website. The Draw will produce eight (8) winners, each of whom will win one (1) invitation for two to specific events/concerts of the SNFCC S.A. at Stavros Niarchos Hall or at the Lighthouse. SNFCC S.A. will determine at its sole discretion in which events/concerts each invitation may be used.

The Draw will also produce eight (8) alternate winners.

- **5.** The prizes are specific and personal and can neither be redeemed for money nor exchanged for others, albeit of equal value.
- **6.** Winners: The names of the winners will be posted after the Draw has been completed on the Website of the SNFCC S.A., where participants can learn the outcome of the Draw. Each winner may use the Prize within an exclusive period of one year starting from the date of the Draw, provided that on the date of receipt/use of the Prize they have an active subscription to the Membership Program.

Winners will be notified by SNFCC S.A. via telephone and email (to the email address they have provided during their subscription registration/renewal/activation) within seven (7) days from the

date of the Draw, and will have to notify SNFCC S.A. that they unconditionally accept the prize as set out in these Terms.

If a winner does not accept the prize as set out in these Terms, or they cannot be contacted as outlined above within a period of fourteen (14) days from the date of the Draw, or it is established that their participation was invalid, they lose their right to receive the prize and their place is taken by the first and so on, in the order of their draw, alternate winner, who will also be notified by SNFCC S.A. as set forth above in this Term.

SNFCC S.A. is not responsible in the event that, for any reason, the attempt to contact the winners and alternate winners to inform them of the result of the Draw is unsuccessful.

It is expressly stated that if the winner who has accepted the prize in accordance with the Terms does not use or receive the prize in a timely manner, for any reason, as set out in these Terms — even because of force majeure — they will lose all right to claim the prize, which is permanently lost to that winner.

- **7.** SNFCC S.A. bears absolutely no responsibility for any legal or factual defect existing or appearing in the prizes. SNFCC S.A. bears no liability, criminal or civil, to any lucky winner or third party, for any accident that may occur and/or damage that may be incurred and/or physical or other harm that may be caused to them directly or indirectly related to the prizes, the use of the prizes, or for any other reason.
- **8.** SNFCC S.A. reserves the right to publish photos or video material relating to the receipt of prizes by winners, for promotional purposes, without the winners' right to remuneration and/or compensation.
- **9.** SNFCC S.A. is entitled to unilaterally amend these Terms, indicatively to modify the prizes, etc., for any reason and at any time, after publishing a relevant announcement on the Website.

In addition, SNFCC S.A. is entitled to cancel, interrupt or postpone the Draw, for any reason and at any time, following the publication of a relevant notice on the Website.

In the cases referred to above in this Term, those entitled to participate in the Draw shall not acquire any right against SNFCC S.A., nor shall they be entitled to request the completion or continuation of the Draw or any compensation. **10.** SNFCC S.A. will be contacting the winners of the Draw when the SNFCC S.A.'s program of events and concerts is made public. Each winner shall have to inform the Membership Program that they wish to make use of the invitation won within a specified period of time prior to the event, to be determined by SNFCC S.A.

In the event that any of these events is canceled, the winners will be informed by SNFCC S.A.

- **12.** In the event that any of these Terms is found to be illegal, invalid or void, said Term will cease to apply without affecting the legality, validity and application of all the remaining Terms.

- **13.** Any delay on the part of SNFCC S.A. to exercise its rights shall not mean that it is waiving these rights.
- **14.** These Terms are governed by Greek law. Any disputes that arise, which will not be resolved out of court, will be subject to the exclusive jurisdiction of the courts of Athens.
