

CONSENT FORM FOR THE PROCESSING OF PERSONAL DATA

Dear visitor,

Thank you very much for your interest in receiving updates on the "Stavros Niarchos Foundation Cultural Center" (hereinafter also referred to as "**SNFCC**").

Through this online form you are invited to explicitly provide your consent for the collection and processing of your personal data, and more specifically your e-mail address, in accordance with the present terms, by the "Stavros Niarchos Foundation Cultural Center Single Member S.A."

The Controller of your personal data collected through this website is the société anonyme under the trade name "Stavros Niarchos Foundation Cultural Center Single Member S.A.", with registered seat at 364 A. Syggrou Avenue, 17674 Kallithea, Attica (hereinafter also referred to as "**SNFCC Single Member S.A.**").

Your personal data is collected based on Art. 6 § 1 (a) of the General Data Protection Regulation (Regulation (EU) 2016/679) ("GDPR") exclusively for the purpose of informing you about the news and activities of the SNFCC via e-mail. Your personal data will be kept until you request your deletion from the list of recipients of the updates and, consequently, the termination of receiving updates for the SNFCC.

Your data will be kept in electronic form, and they will be accessed only by persons who are under the control of the SNFCC Single Member S.A. and only at its behest, in accordance with the provisions of the applicable legislation.

In relation to the above-described purposes, the SNFCC Single Member S.A. may communicate your personal data to companies that provide it with communication planning and promotion services, only to the extent that this is necessary for the execution of their obligations to the SNFCC Single Member S.A. and not for their own benefit and always in accordance with the Law.

These companies may be based in countries outside the European Economic Area (EEA). In this case, we will ensure that such non-EEA transfers are lawful and have appropriate safeguards in accordance with Articles 44 et seq. of the GDPR, such as the signing of standard contractual clauses approved by the European Commission by the non-EEA recipients of the data and any additional safeguards. We implement strict physical, electronic and administrative security measures to protect your data from unlawful processing, accidental or unlawful destruction, accidental loss, tampering, unauthorized disclosure or access, and any other form of unlawful processing, as well as for the non-access to them by unauthorized persons, in accordance with the provisions of applicable law.

Although the SNFCC Single Member S.A. implements reasonable measures to protect against viruses and other harmful components, the nature of the Internet is such, that it is impossible to ensure that your access to the Website will be uninterrupted or error-free, or that this site,

its servers or the e-mails, which may be sent by us, will not contain viruses or other harmful elements. The SNFCC Single Member S.A. ensures that encrypted transmission of the data of this electronic form and all appropriate precautionary protective measures for their secure transmission and storage are implemented.

SNFCC Single Member S.A. restricts the use of this website only to adults. Furthermore, the intention of SNFCC Single Member S.A. is not to collect personal data of minors who may have access to its website without the consent of those exercising parental responsibility or any of their guardians. However, given that this is not feasible to ensure, any minor users of the website who provide, through it, their personal data to the SNFCC Single Member S.A., are obliged and expected to have received the consent of their holders of parental responsibility or any of their guardians.

You may access your personal data at any time. In addition, you have the right to request the rectification of your personal data, as well as, if the conditions of the law are met, to exercise the rights of erasure, restriction of processing, data portability and objection. You have the right to withdraw the consent that you have granted, without however affecting the lawfulness of the processing based on it before its withdrawal. Finally, you have the right to lodge a complaint before the Hellenic Data Protection Authority (Kifissias Avenue 1, Athens, 115 23, complaints@dpa.gr).
